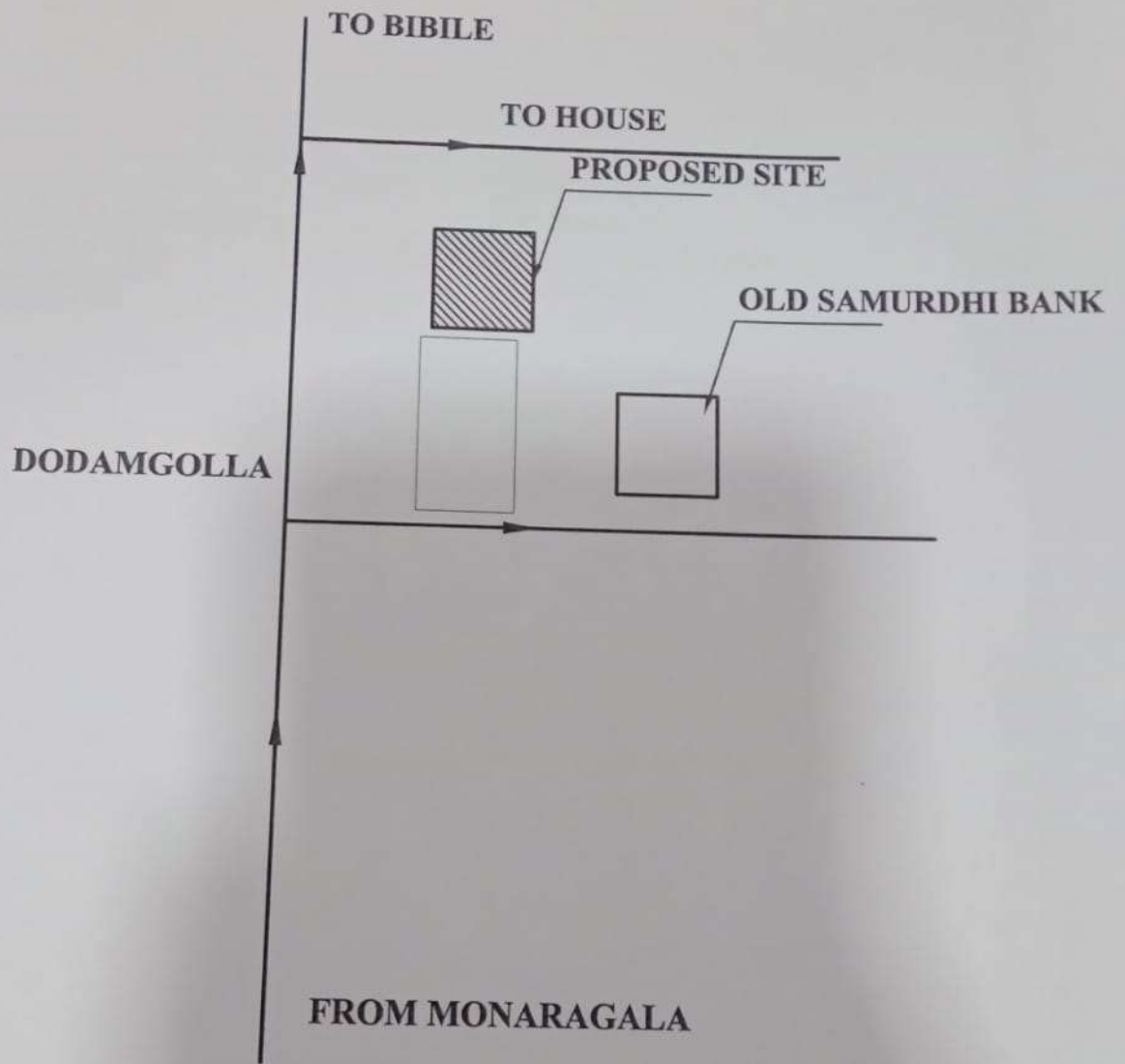

1. The Chairman, Procurement Committee, on behalf of **District Secretariat- Monaragala** invites sealed bids from eligible and qualified bidders for the **Construction of Dodamgolla Samurdhi Bank Building - Bibile (Ground Floor – 1st Stage)** described in section - 4 and total estimate cost is **9.61 million** Rupees.
2. Bidding will be conducted through Limited National Competitive Bidding Procedure.
3. To be eligible for contract award, the successful Bidder shall not have been blacklisted and shall be registered in the field of Building Construction for **C8, C7, C6 and C5** with the Construction Industry Development Authority (CIDA) and valid until the date of closing of Bids. Further registration should be valid at the date of award.
4. For the works above 5 million Rupees, the bidder should be registered under the Public Contract Act No. 03 of 1987 and certificate of registration submitted with the bid. Bids without the certificate of registration or confirmation document for registration will be rejected.
5. Interested Bidders may obtain further information from the **Chief Accountant, District Secretariat, Monaragala (055-2276067)** and inspect the bidding documents at the same office between **09.00 hrs.** and **14.30 hrs.** on working days from **01st September 2026** to **15th September 2026**.
6. Bids shall be addressed to the **District Secretary, District Secretariat, Monaragala** and shall be delivered to with a duplicate to **District Secretary, District Secretariat, Monaragala** to reach at or before **14.30 hrs.** on **16th September 2026**. Submission of late bids will be rejected.
7. Bids will be opened immediately after closing of the submission of Bids **at 14.30 hrs.** on **16th September 2026** **at the Mini Auditorium** of the **District Secretariat, Monaragala** in the presence of the Bidder's representatives who is interested to attend.
8. All Bids shall be accompanied by a Bid Security in favor of the **District Secretary, District Secretariat, Monaragala** and which shall be accompanied by an unconditional on demand. Bank guarantee equivalent in value of **Rs.144,000.00**, which is obtained from a Commercial Bank approved by the Central Bank of Sri Lanka in accordance with the approved format included in **Section 9**, Standard Forms. Bids shall be valid up to **02nd December 2026** and the Bid security should be valid up to **30th December 2026**.
9. A Pre Bid meeting will be held on **07th September 2026** in the office of District Secretary - Monaragala at **10.30 hrs.** Interested Bidders may attend the pre bid meeting at their own expenses.

The specifications should require that all goods and materials to be incorporated in the works be new, unused, of the most recent or current models, and incorporate all recent improvements in design and materials unless provided otherwise in the contract.

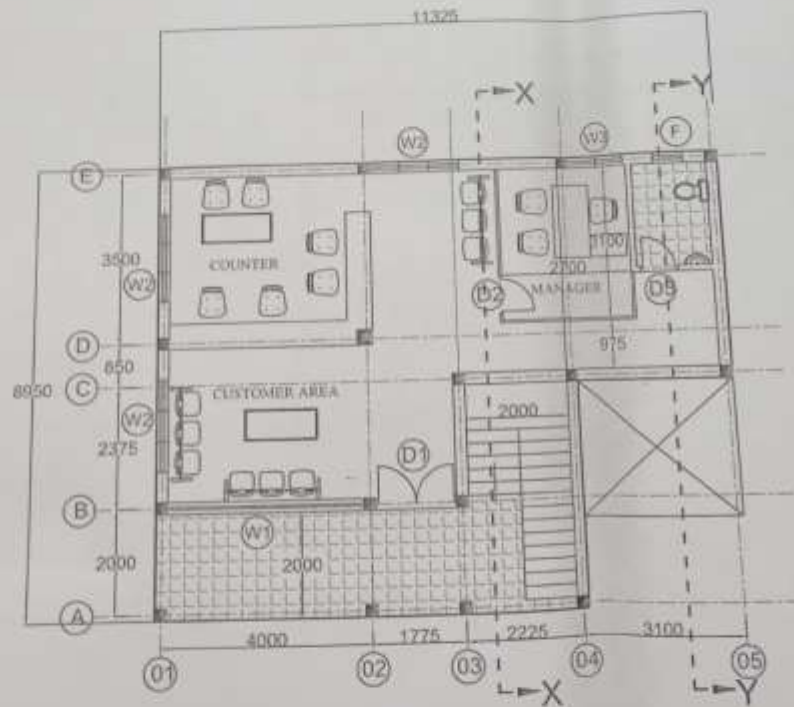

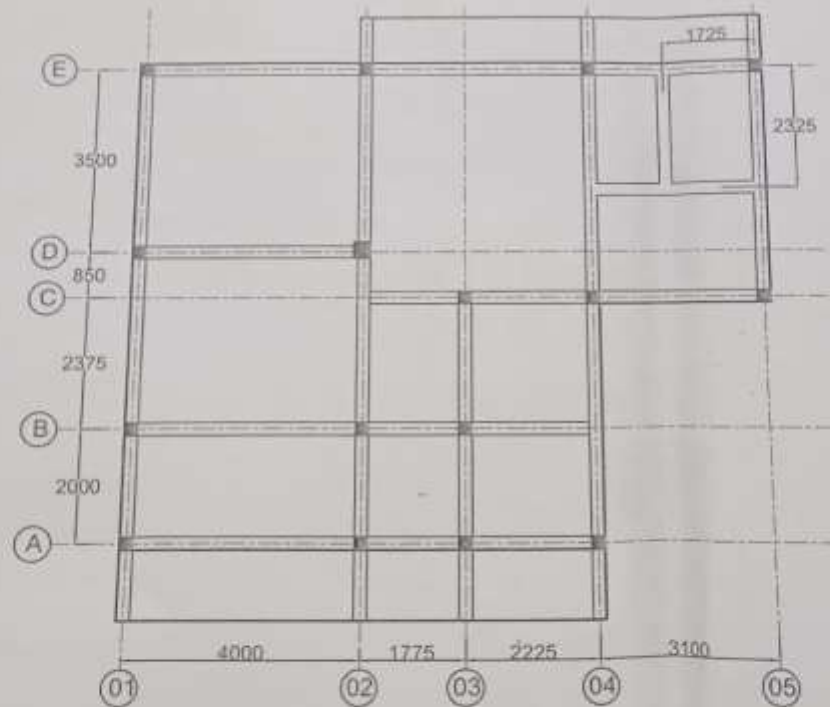

GROUND FLOOR PLAN

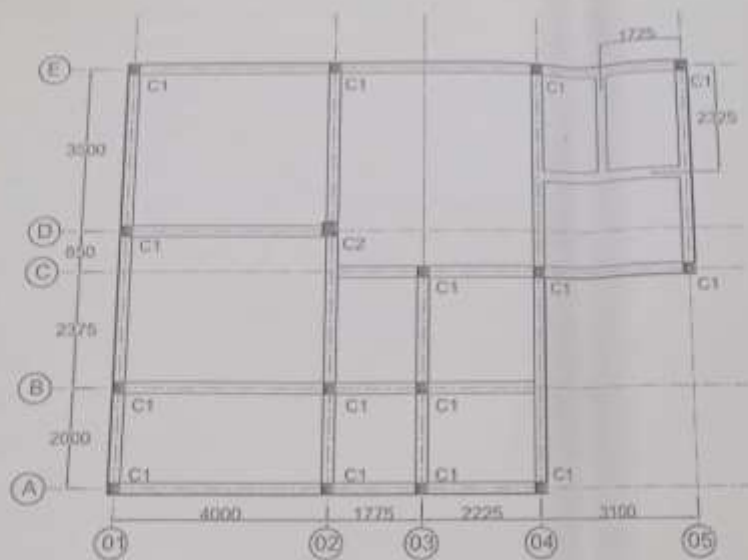

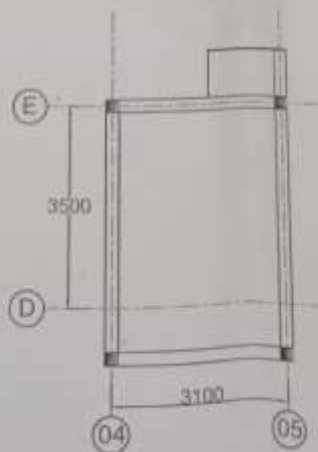
FIRST FLOOR SLAB LAYOUT

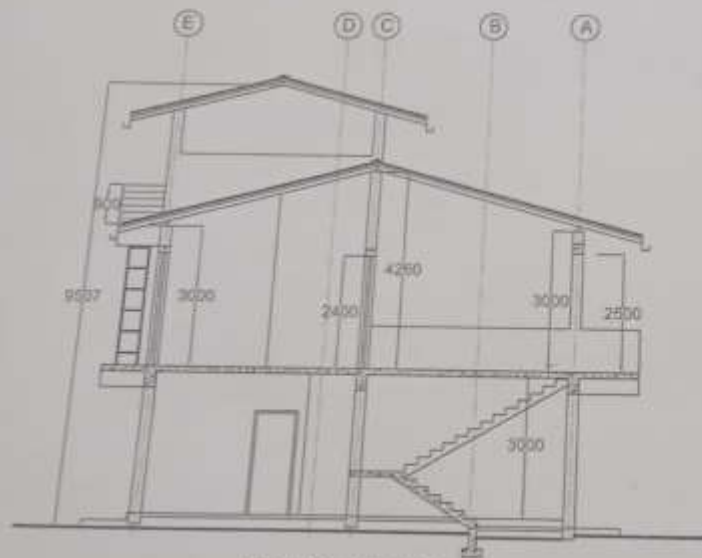
PLINTH BEAM PLAN

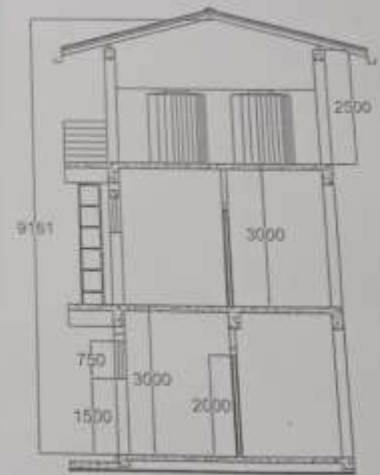


SERVICE FLOOR BEAM LAYOUT

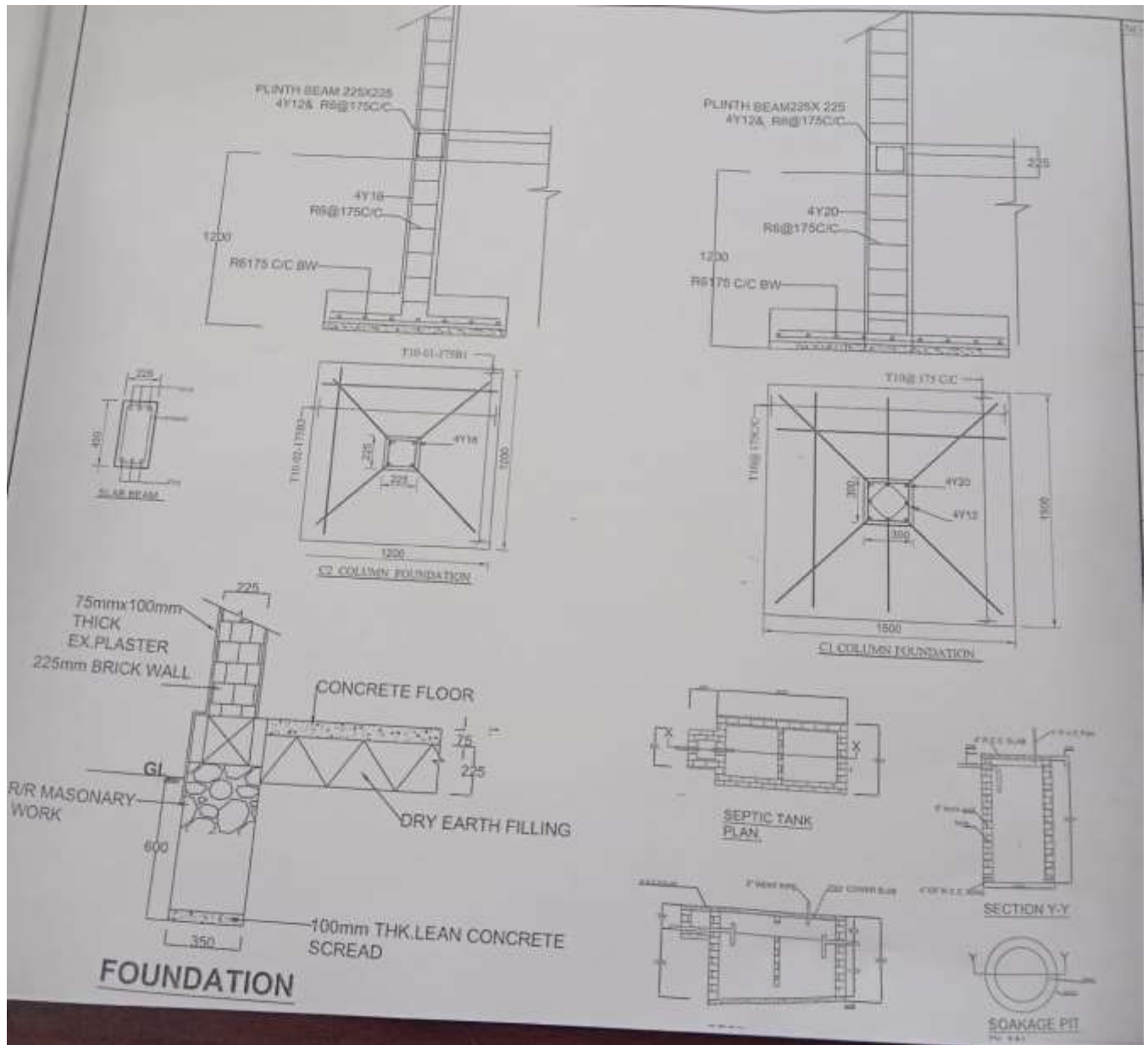
